Financial Aid Options for Domestic Students

Stern Programs

Stern Scholarships	The Stern School of Business awards a number of highly selective, merit-based scholarships to newly admitted full-time applicants with exceptional academic credentials, professional accomplishments, and leadership potential. The scholarship selection process is competitive and awards vary in amounts up to full tuition. If you were selected to receive a scholarship, notification will be in your letter of admission.
Graduate Fellowships & Teaching Fellowships	The Stern School of Business offers fellowships to qualified students. You must have completed at least 9 credits and be in good academic standing. A selection process by administrators and faculty members may be necessary for some positions. Each fellowship provides a partial tuition credit for the semester that you are employed and is credited directly to your tuition account.
Donor Awards	Donor Awards are scholarships that are awarded by NYU Stern Graduate Financial Aid to eligible full-time MBA students and to eligible Langone MBA students who have completed at least 30 credits here at Stern. As the selection process takes place each fall, students must have completed 30 credits by the end of the prior spring semester in order to be considered. The awarded funds can be used to cover tuition only. In most cases, no application is necessary as we consider all eligible students for this type of award.

There are three necessary steps you must take in order to secure your federal loans:

- 1. Officially accept your award with the Stern Graduate Financial Aid Office. You will receive instructions on how to accept your loans via your Stern e-mail account.
- 2. Electronically sign your Direct Loan Master Promissory Note(s) at <u>studentloans.gov</u>.
- 3. Complete an entrance counseling session on-line at studentloans.gov.
