## Langone Fall Semester Registration

### Important Reminders

- Langone Part-time MBA students will register for **6.0 credits**, two Core courses at 3 credits each.
- In your first semester, you must complete or establish proficiency in **Leadership in Organizations** and one of the Basic Core courses:
  - Statistics & Data Analysis
  - Financial Accounting & Reporting
  - Firms & Markets
- For students enrolled in the Washington Square weeknights option, please rank your Core Group preferences in the on-line registration form.
- You will receive confirmation of your final course schedule from the Registration Office.
- In your second semester, you are expected to complete or establish proficiency in the remaining two Basic Core courses.
- Completion of **60 credits** is required to earn the MBA degree.
- Most Core courses are valued at 3.0 credits, while some are valued at 1.5 credits. Electives are valued at 3.0 or 1.5 credits.

## Establishing Proficiency

You may be able to **establish proficiency** in one or more of the Core classes if you:

- Have earned an Undergraduate major or Masters degree in that subject,
- Have taken 5 or more courses in that subject,
- Have passed a **Stern Proficiency Exam**, or
- Can provide proof of U.S. CPA license or passing grade on exam, or chartered accountant certification (for Financial Accounting & Reporting only).

COR1-GB.1306 Financial Accounting & Reporting	US Accounting Majors, US CPAs, Chartered Accountants (Students who have a CFA designation are required to take the Proficiency Exam, per the Accounting Department's policy)

COR1-GB.2311 Foundations of Finance	Finance** (Students who have a CFA designation are required to take the Proficiency Exam, per the Finance Department's policy)

FINC-GB.2302 Corporate Finance ( <i>Elective - See note below</i> )	Finance** (Students who have a CFA designation are required to take the Proficiency Exam, per the Finance Department's policy)

\*Substantial coursework in Organizational Behavior or Organizational Theory required. Proficiency established upon review and approval of transcripts.

\*\* Students need to review the Foundations of Finance and Corporate Finance Core Topic Lists and declare that they feel proficient in the material. Students wishing to Establish Proficiency in Corporate Finance must have taken at least 5 courses in Finance, including at least one course in Corporate Finance.
