Financial Aid Options for International Students

Stern Programs

Stern Scholarships	The Stern School of Business awards a number of highly selective, merit-based scholarships to newly admitted applicants with exceptional academic credentials, professional accomplishments, and leadership potential. The scholarship selection process is competitive and awards vary in amounts up to full tuition. If you were selected to receive a scholarship, notification will be in your letter of admission.
Graduate Fellowships & Teaching Fellowships	The Stern School of Business offers fellowships to qualified students. You must have completed at least 9 credits and be in good academic standing. Eligibility may be contingent upon visa status. A selection process by administrators and faculty members may be necessary for some positions. Each assistantship provides a partial tuition credit for the semester that you are employed and is credited directly to your tuition account.
Donor Awards	Donor Awards are scholarships that are awarded by NYU Stern Graduate Financial Aid to eligible full-time MBA students and to eligible Langone MBA students who have completed at least 30 credits here at Stern. As the selection process takes place each fall, students must have completed 30 credits by the end of the prior spring semester in order to be considered. The awarded funds can be used to cover tuition only. In most cases, no application is necessary as we consider all eligible students for this type of award.

External Financial Aid Programs

Private Grants & Scholarships	Many organizations offer support for international students and we encourage you to explore these private grant and scholarship opportunities. Please visit the Admitted Student Website for information on scholarships offered by corporations that have partnered with Stern. You should also contact any civic, fraternal, religious, or service organizations with which you are already affiliated to see if they offer any assistance.
Government Support	Some countries provide support for their citizens who are studying in the United States. Contact your country's ministry of education, embassy, or consulate about possible funding.
Corporate Support (Employer Sponsorship)	You should inquire with your employer about any financial support available within your corporate organization. Contact your supervisor or human resources department for information.
