The Effects of Asymmetric Regulations: Urgent Care Centers Versus Emergency Departments (Job Market Paper)

Federal regulations require hospital emergency departments to provide care to all patients, regardless of ability to pay or insurance status. However, urgent care centers are not subject to the same regulations and I investigate the consequences of recent growth in the private urgent care industry on the U.S. market for emergency services. In this asymmetrically regulated environment, I find that the entry of urgent care centers has had a significant and differential impact on demand for hospital emergency department care. I present empirical evidence of non-random patient sorting and differentiation by diagnosis and patient characteristics. I estimate a structural consumer level demand system for emergency department and urgent care services in the absence of patient-level urgent care data and use this empirical framework to investigate the welfare and hospital-level implications of symmetric regulations and additional private urgent care entry.
