**Course Content and Objectives:** This course teaches accounting knowledge related to financial reporting for business acquisitions, and foreign currency transactions. Most chapters are taught by two lecture sessions, followed by the homework session. Homework questions will be assigned before the lecture session and some questions will be discussed during the homework session.

Students who complete this course will demonstrate the ability to apply the equity method, consolidate the financial statements of the parent company and the subsidiary, understand the basic concepts of VIEs and deferred taxes, account for foreign currency forward contracts, and translate foreign currency financial statements.
