ABOUT OUR SPEAKER

Paul A. Volcker was born in 1927 in Cape May, NJ. He graduated from Princeton University in 1949, received an M.A. in political economy and government from Harvard University in 1951 and attended the London School of Economics. He has honorary degrees from several universities, including Princeton, Harvard and London.

In the course of his career Mr. Volcker worked in the Federal Government for almost 30 years, serving in high office under five presidents. He was Chairman of the Board of Governors of the Federal Reserve System from 1979 to 1987. Initially appointed by President Carter, he was reappointed in 1983 by President Reagan.

Mr. Volcker retired as Chairman and Chief Executive Officer of Wolfensohn & Co., Inc. upon the merger of that firm in 1996 with the Bankers Trust company, of which

Mr. Volcker became director. He is currently the Henry Kaufman Visiting Professor at the Stern School of Business, New York University. He also serves as a director of, or consultant to, a number of corporations and non-profit organizations.

When Professor Seymour Jones retired from Coopers and Lybrand, LLP, in 1995 his colleagues, friends and family established the Seymour Jones Distinguished Lectureship in his honor. The purpose of the annual lecture - to be given by a distinguished member of the accounting profession, official of a government or a regulatory body, judge, or legislator - is to encourage interaction between the profession and academe.

The Inaugural Lecture, entitled The Role of Financial Reporting in US Capital Markets, was given by Michael Sutton, Chief Accountant of the SEC, on November 25, 1996. The second lecture, entitled Auditor Independence in the 21st Century, was given by William Allen, Director of the Center for Law at New York University, with a commentary by Philip Laskawy, Chairman and CEO, Ernst & Young, on November 24, 1997. The most recent lecture was given by Paul A. Volcker, Henry Kaufman Visiting Professor of the Stern School of Business and Former Chairman of the Federal Reserve Board, on October 19, 1998.
