COURSE OBJECTIVES:

- 1. Understand the theory, concepts and procedures utilized in the accounting process.
- 2. Recognize the relationship the four financial statements (balance sheet, statement of operations, statement of stockholder's equity and the statement of cash flows, along with the accompanying footnote disclosures) have to the evaluation a business transaction. This understanding will assist you in becoming sophisticated users of the financial statements, each of which tell part of the story about the company's performance.
- 3. Supplement the course material with real world applications to put the financial issues we will cover into context.

ASSIGNMENTS / GRADING:

There are reading and/or problem assignments for each class. *The homework assignments are clearly listed in Connect. The assignments need to be completed and will be graded in Connect.* It is recommended that in addition to the homework assignments, you review the self-study items contained within each chapter in Connect if you are having difficulties with the homework assignments.

Past semesters have shown a strong correlation between class attendance and overall course performance. The material we cover in class supplements the material in the book. Therefore, reading the book is a compliment (not a substitute) for attending class. I understand that over the course of 28 sessions, personal and religious conflicts come up and you may need to miss a class. If you miss class, please ensure to stay updated and review the material that you missed</u>
