Stern Faculty Committee Descriptions

Nominees for all elected committees are selected by the Faculty Council. The slate consists of three nominees for each vacant position. Faculty members on full year sabbatical or leave defer their service and are replaced by an interim appointment, made by the Faculty Council. Shorter leaves/sabbaticals are not replaced.

Academic Programs and Teaching Resources Committee

Provides faculty oversight of school-wide curriculum and teaching issues. Its charge includes instituting and reviewing all policies and procedures that promote excellence in teaching. In addition, it provides a forum for coordinating school wide programs and teaching resources across departments. The work of this committee may originate with the committee itself, or it may handle appropriate assignments requested by other committees or the school's administration. *(Five associate or full professors, either tenured or clinical, 3-year terms, all elected. Elected by tenure-line and clinical faculty.)*

Faculty Council

The Faculty Council is the voice of the faculty with respect to academic and governance issues. It represents the concerns of the Faculty and manages the Standing Committees of the Faculty. One of Stern's two alternates serving on the NYU Senate's Continuing Faculty Council serves as an *ex officio* non-voting member of the Stern Faculty Council. *(Seven associate or full professors, five tenured and two clinical, 3-year terms, all elected. Elected by tenure-line and clinical faculty. At least one clinical faculty member must be on the ballot when there is a vacancy.)*

Faculty Grievance Committee

The Grievance Committee makes recommendations to the Dean with respect to responses to faculty originated complaints of unfair treatment. The Committee is not institutionally equipped to render legal opinions; rather its orientation is the requisites of fairness in an academic community. Work of the committee is initiated by the filing of written grievance with the Vice Dean for Faculty and Research, who then communicates that grievance to the Committee. The clinical professors do not hear cases brought by tenure-line faculty. *(Five full tenured professors and two clinical professors, 3-year terms, all elected. Elected by tenure-line and clinical faculty.)*

Faculty Disciplinary Committee

As required by NYU, the Disciplinary Committee makes recommendations to the Dean with respect to responses to faculty originated complaints of unfair treatment. The Committee is not institutionally equipped to render legal opinions; rather its orientation is the requisites of fairness in an academic community. Work of the committee is initiated by the filing of written grievance with the Vice Dean for Faculty and Research, who then communicates that grievance to the Committee. The clinical professors do not hear cases brought by tenure-line faculty. *(Five full tenured professors and two clinical professors, 3-year terms, all elected. Elected by tenure-line and clinical faculty.)*

Financial Affairs Committee

This committee receives information on Stern's financial status, shares this information with Stern faculty to increase awareness about the School's financial health, encourages accurate, fact-based dialogue on these issues, provides input into school-wide financial activities, and advises the Dean on the Stern School's

stewardship and allocation of financial resources. The Committee works directly with the Dean and Chief Operating Officer on risk assessment by providing input on the School's strategic plan to manage and mitigate risk. *(Five associate or full professors, either tenured or clinical, 3-year terms, all elected. Elected by tenure-line and clinical faculty.)*

Honorifics Committee

This committee recommends professors for endowed chairs and faculty fellowships on a bi-annual cycle (odd years) and as needed. Final appointments are made by the dean. *(Four full professors who hold endowed chairs, 6-year terms, all appointed by the dean.)*

Promotion and Tenure Committee

This committee evaluates candidates for tenure after their departmental review. It reviews the P&T materials and hears a presentation by a senior member of the department. It then votes and submits its recommendation to the dean. *(Six full professors from different department, 3-year terms, all appointed by the dean.)*

Research Resources Committee

This committee provides faculty oversight of all policies and procedures that promote excellence in faculty research. Its charge includes determining the best acquisition and use of resources across departments. The work of this committee may originate with the committee itself, or it may handle appropriate assignments requested by other committees or the school's administration. *(Four ex-officio members: Faculty Director of Stern Center for Research Computing; Chief Information/Operating Officer; Director of Doctoral Education; Vice Dean for Faculty and Research.)*

Senior Faculty Peer Review Committee

Comprised of tenured faculty, SFPRC reviews all associate professors who have been tenured for ten years or longer and full professors who have held that rank for six years or longer. All faculty in these two categories are to be reviewed at least every six years. The goal of the review process is to enhance and energize the pool of faculty talents that are essential to achieving the goal of school-wide excellence. *(Five tenured full professors who hold an honorific. Exceptions: deans, department chairs, deputy chairs, current SFPRC members, professors from departments with 2 members already on committee, professors retiring in next 2 years, or on sabbatical or leave in next academic year), 3-year terms, three elected, two appointed by dean. Members elected by tenured faculty.)*

NYU Faculty Committee and Senate Descriptions

University Senate

The University Senate, chaired by the President, is the chief deliberative body of the University for the discussion of all matters of University policy and practice in cases in which two or more schools have a substantial interest.

(Tenured/Tenure-Track Council: Two tenured members, two alternates, 3-year terms, all elected by tenure-line faculty.

Continuing ("Clinical") Council: One clinical faculty member, two alternates, 3-year terms, all nominated and elected by clinical faculty.

University's Teaching Advancement Grant Review and Selection Committee

This committee reviews applications and selects awardees for the Teaching Advancement Grant (TAG), which is sponsored by the Center for Faculty Advancement with the goal of developing innovative curricular programs and projects at NYU.

NYU Faculty Committee on Global Network

This committee engages the full-time faculty at NYU in all academic issues related to the global network. *(Two associate or full professors, either tenured or clinical [full-time appointment at NYU], 3-year terms. Appointed by Faculty Council.)*

NYU Graduate Program Committee (GPC)

The Graduate Program Committee has the power to review and recommend to the Provost the approval of proposals from colleges, schools, and portal campuses with respect to new graduate programs granting master's and doctoral degrees. The Committee also may formulate recommendations to the Provost on other matters that relate to graduate education in the University. *(One associate or full professor, either tenured or clinical, 3-year term. Appointed by Dean.)*

NYU Faculty Committee on the Future of Technology-Enhanced Education

The charge for this group is to facilitate the process of developing a vision for the future of teaching and learning at the University, especially as it relates to the use of technology innovations. *(One associate or full professor, either tenured or clinical, 3-year term. Appointed by Faculty Council.)*

NYU Teaching Quality Committee

The charge of this committee is to research, review, and recommend best practices to define, support, measure, and honor teaching excellence at NYU.

NYU Undergraduate Academic Affairs Committee (UAAC)

The UAAC focuses on undergraduate student academic life, and comprises distinguished members of the faculty and student body from across the university. *(One associate or full professor, either tenured or clinical, 3-year term. Appointed by Dean.)*

NYU Undergraduate Program Committee (UPC)

The UPC advises the Provost on proposals from colleges, schools, and portal campuses for new undergraduate majors and degree programs, as well as for cross-school minors. *(One associate or full professor, either tenured or clinical, 3-year term. Appointed by Dean.)*

NYU Doctoral Affairs Council

NYU's Doctoral Affairs Council is charged with sponsoring university-wide initiatives to strengthen the doctoral student experience across NYU. *(Director of Doctoral Programs. Appointed by Dean.)*

NYU Reads

NYU Reads brings the NYU community together around a single common reading, chosen by a university committee made up of faculty, student, and administrator representatives. *(Appointed by Dean.)*
