COURSE DESCRIPTION

The course is intended for students with no previous exposure to financial accounting. The objective is to help you become intelligent readers of the financial reports of publicly traded companies. The course focuses on the development, analysis, and use of these reports. It also provides an understanding of what these reports contain, what assumptions and concepts accountants use to prepare them, and why they use those assumptions and concepts. A solid understanding of the fundamentals covered in this course should enable you to do well in more advanced finance and accounting courses and to interview intelligently for jobs in finance and consulting.

The course begins with the basic concepts of accounting. We look at the main financial statements: balance sheet, income statement, statement of cash flows, and statement of stockholders' equity. Particular attention is paid to how these four statements relate to each other and how they provide information about the financial health of a company. We then cover specific items from the financial statements and apply tools of analysis whenever possible. Keep in mind that the objective of this course is not to train you to become an accountant but rather to help you develop into an informed user of financial statement information. Therefore, our perspective is that of *external* users of financial information, such as investors, creditors, customers, suppliers, government regulators, and, of course, business school students.

COURSE MATERIALS

Textbook (optional): For this course, the recommended textbook is Libby, Libby, and Hodge, *Financial accounting*, 10th edition provided by McGraw-Hill Education Connect® access. The Connect platform will provide full access to the eBook and (ungraded) practice questions. Please be aware that if you purchase a used textbook, you will still need to purchase Connect access to be able to use the online material in the Connect platform.

The textbook is not required but recommended. In our efforts around affordability, we have a few options for our students as follows:

- Online All Digital (most affordable option): You can purchase Connect (without the print book, but this includes the complete eBook and access to all course content) directly from the course website for \$149.13. McGraw Hill also provides temporary access for 14 days, which you can use to see whether the material is worth purchasing.

Accounting Standards Codification: While not a natural component of an introductory financial accounting course, you should be aware that, as of September 2009, all extant GAAP can be found in the Accounting Standards Codification (ASC). The ASC is a single, searchable database of GAAP with hyperlinks to implementation guidance and examples. The ASC also includes a master glossary with hyperlinks to all uses of terms in GAAP that you might find useful. At some point during the course, I will log on to ASC and briefly demonstrate how it can be used. Each component of the class is discussed in detail below.

Homework: After we have concluded each class topic, assignments will be due that will give you an opportunity to show me, and yourself, that you have understood and learned the material. There will be 6 homework assignments, and you only need to submit 5 of them. If you hand in all 6, the highest 5 scores will be counted in your grade. You must submit your completed homework on Brightspace before 11:59 pm on the date due; late homework will be penalized. I will not accept assignments over the web, through e-mail, etc. Solutions to homework will be posted to Brightspace.

You are welcome and encouraged to discuss and work on homework problems with your classmates. However, all of you must individually submit your own answers via Brightspace.

Exams: There will be three exams, two midterms (non-cumulative) and one final (cumulative). Although the final exam is cumulative, the emphasis will be on the material covered since the last exam. All exams are open book/open note, but you must finish them by yourself and cannot communicate with anyone else.

<u>Exam dates will not be rescheduled for any individual student.</u> If you miss any exam, you will receive zero credit for that exam. The midterms will be administered during class time on Tuesdays.

SmartBook: This is your online reading available in the Connect platform. I have selected material from each chapter for you to read as indicated in the syllabus and set up questions related to that material. SmartBook is an adaptive reading experience so it will guide you to spend the most amount of time on material you are least familiar with and will not spend extra time on material you already know. SmartBook will work well for you if you read all the material (not just material highlighted in yellow) and answer the SmartBook questions honestly. Each time you answer a question, SmartBook will prompt you to rate your confidence in your answer. An honest answer will result in the most learned in the least amount of time. This is not graded but intended to ensure you read and understand the material.

Extra Practice Problems: In addition to the graded assigned homework, I will suggest additional practice problems. Out of respect for your busy schedules, these problems will not be due or part of

your grade. However, you should complete them to ensure sufficient reinforcement of the material. The suggested practice problems will be from the textbook itself, but your textbook and Connect include even more practice problems that you can solve for areas that you find particularly challenging.
