#### Alia Jones-Harvey

Alia Jones-Harvey, an Olivier Award Winning and Tony Nominated Producer, is a partner at Front Row Productions, a theatrical production company that she joined seven years ago to bring classic works featuring actors of color to the Broadway stage. Jones-Harvey and her partner, Stephen C. Byrd, are currently the only African American lead producers on Broadway.

In her Broadway debut, Jones-Harvey co-produced the first African American revival of Tennessee Williams' Cat on a Hot Tin Roof, the biggest grossing play on Broadway in Spring 2008. The production's all-star cast featured James Earl Jones, Phylicia Rashad, Terrence Howard and Anika Noni Rose, with Debbie Allen as director. Currently, Jones is producing Horton Foote's The Trip to Bountiful, on Broadway. Directed by Michael Wilson and featuring Cicely Tyson, Cuba Gooding Jr, and Vanessa Williams, the production was nominated for four Tony Awards, and Tyson took home the award for Best Actress for her soul-stirring

performance in the leading role. The production has extended its run to October 9, 2013.

For 15 years prior to joining Front Row Productions, Jones-Harvey gained expertise in financial analysis, reporting and marketing campaign development for consumer brands, financial products, web-based educational curriculum and arts organizations. She began her career with Procter & Gamble in Global Perfumes, Finance & Accounting and Interactive Marketing. Her responsibilities included software design and development, financial reporting, and implementation of web-based marketing solutions for P&G brands. Jones-Harvey worked for six years in financial services with Lehman Brothers and Stonehedge Partners in private client services, hedge fund marketing and hedge fund administration.

Originally from Largo, Maryland, Jones-Harvey earned, concurrently, a Bachelor's Degree in Mathematics from Spelman College and a Bachelor's Degree in Industrial Engineering from the Georgia Institute of Technology (Georgia Tech). She completed her MBA in Finance and Marketing at the New York University Stern School of Business. With a commitment to education, innovation and the arts, Jones-Harvey serves on the Board of The National Urban Technology Center and is an active member of The Broadway League Speaker's Bureau. In 2012, she was honored with the What's the 411 Networks Salute to Black Broadway Vanguard Award and the Beverly Hills/Hollywood NAACP Theatre Trailblazer Award. She is married to Phillip Harvey, Africana Studies Faculty at John Jay College of the City University of New York.

Barry Salzberg is the global Chief Executive Officer of Deloitte Touche Tohmatsu Limited (DTTL). He assumed this position on 1 June 2011. As DTTL CEO, Salzberg leads and manages the Executive and sets the strategic direction of the Deloitte global network. The global network comprises 47 member firms operating in 150 countries, with approximately 200,000 people worldwide. Salzberg is a member of the DTTL Board of Directors and Executive committee.

Prior to this role, Salzberg served as Chief Executive Officer of Deloitte LLP (United States) from 2007 to 2011, and as the U.S. Managing Partner from 2003 to 2007. During his time as CEO of Deloitte LLP, he was a member of the U.S. Board of Directors, the DTTL Executive committee, the DTTL Board of Directors, and served as the Americas Regional Managing Partner. Salzberg joined the Deloitte organization in 1977 and was admitted as partner of the Deloitte U.S. member firm in 1985. He has since built an impressive record through a variety of leadership roles.

In his earlier career, Salzberg was a lead client service partner and tax partner of the Deloitte U.S. member firm and became an acknowledged authority in the areas of personal tax and partnership tax matters. In this role, he directly served the CXOs of many large clients, helping them with their personal tax and financial planning needs, as well as partnerships and S corporations, mostly law firms or merger and acquisition specialists.

Salzberg is a member of the New York State Bar Association, the American Institute of Certified Public Accountants, the New York State Society of Certified Public Accountants, and the New York County Lawyers' Association. He is a member of business organizations including the Japan Society, BritishAmerican Business International Advisory Board and the United States Council for International Business, and has been a board member of the Committee Encouraging Corporate Philanthropy, the Business Roundtable and the Center for Audit Quality.

### Dr. Brent Ridge

Dr. Brent Ridge and his partner Kilmer-Purcell are the stars of The Fabulous Beekman Boys, a hit television reality series airing on the Cooking Channel.

When Dr. Ridge and Josh Kilmer-Purcell bought the Beekman Farm in upstate New York in 2008, they didn't just start a farm, they started a movement. A mere five years later they already have a hit TV show, bestselling books, product lines in leading retailers, a massive social following, and a James Beard nominated lifestyle website. They've been featured in most major media outlets, including The New York Times, USA Today, Vanity Fair, The Martha Stewart Show, Rolling Stone, Dr. Oz, Vogue, The Rosie O'Donnell Show, Rachel Ray, WSJ, O Magazine, and more.

Their farm and surrounding community serves as the inspiration for their lifestyle brand, "Beekman 1802." The brand's signature beauty, home & food products can be found on the shelves of Henri Bendel,

Anthropologie, Williams-Sonoma and other national retail partners. The Beekman 1802 cookbook was launched on QVC to record sales, and the memoir of their farm life, The Bucolic Plague, was a national best seller. The 2011 launch of their Beekman 1802 Blaak Cheese resulted in a wait-list of over 7500 people. The Fabulous Beekman Boys is currently airing on Cooking Channel three days per week.

In 2012, CBS announced that Ridge and Purcell had been cast in the 21st season of The Amazing Race, ultimately becoming the season's grand prize winners. Dr. Ridge was a geriatrician at Mt Sinai Hospital, and later became the Vice President of Health and Wellness at Martha Stewart Omnimedia, making regular appearances on The Martha Stewart Show. Dr. Ridge also writes for Huffington Post.
