KEYNOTE SPEAKER

STEPHEN A. ROSS

Franco Modigliani Professor of Finance and Economics, MIT

Stephen A. Ross is Co-chairman of Roll and Ross Asset Management Corporation (Roll and Ross), a partner in IVC International Limited (IVC), and the Franco Modigliani Professor of Finance and Economics at MIT. He was previously the Sterling Professor of Economics and Finance at Yale University and, before that, a professor of economics and finance at the Wharton School of the University of Pennsylvania.

Professor Ross is the author of more than 100 articles in economics and finance and is the coauthor of a series of introductory textbooks in finance. He received his B.S. with honors from CalTech in 1965 where he majored in physics, and his Ph.D. in economics from Harvard in 1970. While he has worked on a wide variety of topics in economics and finance, he is probably best known for having invented the Arbitrage Pricing Theory and the Theory of Agency, and as the co-discoverer of risk neutral pricing and of the binomial model for pricing derivatives. Models developed by him and coworkers, including term structure models and option pricing models, are now standards for pricing in major securities trading firms. He has been the recipient of numerous prizes and awards, including the Graham and Dodd Award for financial writing, the Pomerance Prize for excellence in the area of options research, the University of Chicago's Leo Melamed Prize for the best research by a business school professor and the 1996 IAFE Financial Engineer of the Year Award. A Fellow of the Econometric Society and a member of the American Academy of Arts and Sciences, he currently serves as an Associate Editor of several economics and finance journals and in 1988 was President of the American Finance Association.

DAVID KRELL

President & CEO, International Securities Exchange (ISE)

David Krell is a founder and President & CEO of ISE. From 1997 to 1998, he was Chairman and co-founder of K-Squared Research, LLC, a financial services consulting firm. From 1984 to 1997, Mr. Krell was Vice President, Options and Index Products, of the New York Stock Exchange where he managed marketing, systems and new product introductions for the division. From 1981 to 1984, Mr. Krell was First Vice President at the Chicago Board Options Exchange, responsible for the management and operation of the Marketing and Sales Division, Mr. Krell was also a Vice President of Merrill Lynch from 1978 to 1981 and founded its Managed Options Service.

Mr. Krell is active in numerous industry groups. He was a Director on the Board of the International Federation of Technical Analysts, a president of the Market Technicians Association and a Director on the Board of The Options Clearing Corporation.

Mr. Krell formerly was an Adjunct Professor at Rutgers University Graduate School of Management and at the Graduate School of Baruch College. He has taught, coordinated and directed numerous seminars and workshops at the New York Institute of Finance.

Altman (past FMA President); Derivatives Research Project directed by Stephen Figlewski (Founding Editor, Journal of Derivatives); Financial Econometrics directed by Robert F. Engle (2003 Nobel Laureate in Economics); Financial Institutions directed by Alexander Ljungqvist; and Macro Finance directed by Thomas Sargent (Senior Fellow at Hoover Institution). Each initiative holds periodic research meetings of faculty, PhD students and practitioners; produces a working paper series; publishes an annual newsletter and hosts a "high profile" academic conference every two-three years with the goal of bringing together the top academics worldwide in this initiative.
